Opening prayer

- A. Call to order by the County Judge Executive, Scott Travis
- B. Roll call by the Spencer County Clerk, Lynn Hesselbrock- all present
- C. Approval of minutes from the prior meeting of December 19, 2022
 - Motion made by Esq. Cotton, seconded by Esq. Pharris, with all members of the Court present voting "aye" by voice vote, it is hereby ordered to approve the minutes from the December 19, 2022, meeting with any corrections being made.
- D. Communications from the County Judge Executive
- 1. The Judge remarked that they had a lot of rain yesterday and if it had rained again, they would be having a lot of problems. The Judge mentioned that the floodwall protects property that belonged to the entire county. He and Esq. Pharris had attended some Floodwall committee meetings. He said that they were supposed to collect around \$60,000.00 per year but fell short. He was going to work with the city and others to ensure the collection of the fees necessary to do their jobs. Having the floodwall in place allowed those who were within it, to not have to purchase flood insurance.
- The Judge wanted to open the floor up to the Magistrates to say a few words.

a. Esq. Cotton remarked that he would like to look at employee benefits. He suggested getting other companies to come in and try and bring employee costs down.

b. Esq. Stump remarked that he was excited to be there and excited to get started. He said that they would be looking at employee pay and benefits. He also said that he felt that in the past there had not been as much attention to accountability and transparency in some of those things. He said that he hoped this Court would pay more attention to the taxpayer dollars. He said that they would have discussions and there would be some rocky roads but hoped that at the end of their term, people would think that they were in a better place than when they took office.

c. Esq. Travis remarked that he wanted to commend this Court for what they accomplished. He said that they made probably four major decisions, important decisions, in one meeting. He went on that in the past four years, the Court that he was on, made nothing like the major decisions that they had made, He said that they had accomplished in two hours that they had not in four years, and he just wanted them to know that is how they were working together.

d. Esq. Pharris remarked that he was probably the least familiar to the audience. He introduced himself as the Taylorsville District Magistrate. He wanted to make Spencer County a better place to live because it was his home. His goal was to work with the Court and continue the work that they did yesterday. He said that they needed to take care of their employees as well as take care of their citizens.

e. Esq Eldridge introduced himself as the Mt. Eden, Little Mount Magistrate. He thought this was a good Court, they would get a lot accomplished, and he looked forward to the next four years.

f. Mr. Cory Thomas introduced himself as the new County Attorney He looked forward to advising Fiscal Court and the County elected officials.

The Judge remarked that they all knew Doug, the County Treasurer. Mr. Williams remarked that his term ended in June of this year. He looked forward to the next four years and remarked if anyone had any questions to let him know. He has worked for the County for 33 years.

E. Communications from members, other offices, and committees.

1. Zoning readings- Julie Sweazy

Ms. Sweazy had nothing to report.

2. Safety committee-Esq. Pharris

Mr. Pharris had nothing to report.

3.

Solid waste committee-Esq. J Travis

Esq. Travis had been in discussion with Rumpke about curbside recycling pickup. The Judge remarked that Karen needed a gate out at the Recycling center. He said he would get with Todd Burch and get a couple of cattle gates and get them installed. Esq. Travis remarked that the Solid waste committee worked on getting a chain link fence with a roller that rolled out, they had estimates on it, and he thought that it was \$6,000.00. The last Court never followed through on it. He said that the new medical facility and assisted living facility coming right there, it would make the County's vision, what people look at, in a more positive way. It would be nicer that some farm gates.

4. Veterans committee-Esq. Pharris He had a meeting with the Amvets on Thursday, and he was going to talk to them about getting some to join to be committee members. He was also going to become a member so he could stay in touch with what they had going on. He said that Jack Burns was a member of the VFW and could help

him stay informed of what was going on.

5. Equipment committee-Esq. Cotton

Esq. Cotton remarked they had a Sheriff's vehicle at Daugherty's to have an oil change, set of tires, and brakes put on. It was going to cost around \$1600.00.

6. Telecommunications committee-Esq. Cotton

Esq. Cotton had nothing to report.

7. Administrative Code committee- Corey Thomas

Mr. Thomas had nothing to report.

Tourism & Economic Development committee- Esq. Pharris

Esq. Pharris would be attending a Tourism meeting on Thursday. He would be seeking volunteers for the County Tourism committee. The Judge remarked that this was a new committee. He wanted the community to reach out to them to help them expand. He mentioned the lake and the opportunities it presented.

Animal shelter committee-Esq. Pharris

Esq. Pharris remarked that they voted to look at the property behind the Dollar General yesterday. It was not certain that is where they were going to build it, but it was a first step. He had met with the Animal Control officers and listened to their concerns. He talked to a member of the animal group and would see if she was interested in becoming a member of the committee.

10. Building and grounds committee- Esq. Cotton

Esq. Cotton had nothing to report. He would be meeting with Randy Bush soon.

Parks and recreation committee- Esq. Stump

Esq. Stump reported that he had checked out Waterford Park after the flooding. The playground area had incurred some damage. He mentioned that as the previous Court had reported, the upper pedestrian walkway appeared to be draining sufficiently, however, the crosswalk culvert was

completely clogged up and was not allowing drainage. It was something they would have to look at in the future. He said that he was going to meet with Brian Spencer tomorrow and they were going to go through Waterford Park and Ray Jewell Park to see the extent of the damages. He hoped to have a report for the Court at their next regularly scheduled meeting.

12. Department Heads.

a) Todd Burch- County Road Foreman came before the Court to remark that he has been the Road Foreman for twelve years. He looked forward to working with the Court for them to accomplish what they needed to get done. He said that in the past he had put a budget together and given it to the County Judge and had put a budget request in capital projects. He had put in approximately \$25,000.00 dollars in that line item each year. He could never touch that. The capital projects budget line item was for improvements to the Road facility. He said he would like to use some of that money for upgrades to their facility. He said that they had three trucks coming in, F-550s. He had obtained quotes for spreader boxes and dumps to go on the trucks, but it needed to go to the equipment committee due to the big difference in quote prices. He informed the Court that they were hauling cinders out of Jim Beam distilleries and UK facilities. The EPA has put restrictions on cinders. The County was going to have to make the transition from cinders to salt and investigate building a slat facility. He mentioned that he would like to see improved benefits for his employees. Todd said the most important thing, he thought, was communication. The Judge assured him that the Court was there to support them.

b) Mr. Nick Wilkerson- Acting Animal Control Director came before the Court with an informational packet to illustrate that the County needed to update the Animal Ordinance. They had not had a n update to the ordinance since 2008. The current ordinance was only for dogs. The packet he gave them had an ordinance that was lengthy. He asked them to go through it and highlight what they liked and what they did not like. He had given the ordinance to the previous County Attorney, but he had never gotten back to him. He remarked that the second item he wanted to discuss was cats. He said that there was a large problem with the community or feral cats. They would like to establish a TNR program. A trap-neuter-release program. He remarked that the euthanasia rate for stray cats brought into other counties was near 60%. He said that he had spoken with the mayor-elect to see if they could start the program in the city. He had volunteered to head the program. Esq. Stump remarked that he thought that Mr. Wilkerson's report was a very wellthought-out, factual, articulate, complete, report. He appreciated him having that all laid out, backed up by facts. He had done his research and presented it to the Court, and he could say that this was something that they needed to address. Mr. Wilkerson thanked him. Judge Travis said he was unaware of the large cat problem and that if a cat went to a shelter, it was almost a certain death sentence.

c) Ms. Julie Sweazy came before the Court as the Planning and Zoning Administer. She informed the Court that she had been with the County for 25 years. She said she was the Floodplain coordinator, the 911 coordinator, Planning and Zoning Administrator. She said that they did several different things through the office. She said that there were 8 members of the Planning Commission on a 4-year rotation, there were 5 members of the Board of Adjustments on a 4-year rotation. She said that they were required to get continuing education each year. Staff members must also get continuing education. She continued that they operate under KRS 100. She has two staff members; one is an enforcement officer, and the other is Angie who is an assistant in the office who assisted Ms. Sweazy.

d) Mr. Chris Limpp came before the Court as the Chief of Emergency Services. He has been employed by the County for nearly 20 years. He said they would have to grow to keep up with the growth of the community. He discussed the state of the ambulance fleet. He said their run count had increased and they could use a third ambulance. He reported 1800 runs last year and tripled revenue. He said that they send either a paramedic or Advanced EMT on each run. They had sent 4 of their employees to the Advanced EMT class. They would begin teaching basic and Advanced EMT classes here in the County. Mr. Limpp went on to describe his staffing levels and requirements. He agreed with Esq. Cotton about improving County employee benefits to retain employees. He talked about the future need to move ambulances to other areas of the County to have them closer when the need arose.

e) Ms. Stephannie Smith came before the Court as the Occupational License Administer. In 2007 Fiscal Court enacted two new taxes: a net profit business tax and a payroll tax. At the same time, they lowered the business license fee to \$25.00. She said she shared Ashley with Julie. She went out and did enforcement for building projects and checks for contractors on job sites. She reported that in the calendar year 2022, she collected 1.187 million dollars. She said that as always, compliance was an issue. She worked with taxpayers to educate them on the tax system. She is looking at a system that focused on electronic communication. The system also added penalties and interest for her. Boone County has recently purchased this software and is working through the issues so she will not have to.

f) Mr. Randy Bush came before the Court to tell them he had to get out of there and was going to make it short. He reported that he had been with the County for 10 years as the Superintendent of Buildings. He liked to work on priorities, and he had given them a paper. He said he could give them a whole stack of papers of needs in the County, especially the Courthouse. He said it was falling apart along with every building they had, they needed to be updated. Right now, his priority was gutters on the Courthouse. He had water coming in on two floors. The Judge's office had updated gutters. He wanted everyone to come and see him and see what he did.

g) Mr. Brian Spencer Came before the Court as the Director of the Parks Department. He had a couple of things that he wanted to talk to them about. He said that they needed a sports facility for the youth of the community. He was having an issue with using the schools for the basketball program. There was a conflict between the programs the schools offered and the programs he was offering. The County was growing, and he had 270 plus children in the basketball program. He could only use the schools for practice 2 days a week. He mentioned the problem with parking at Waterford Park. People were parking on the street. There was a problem with the utilization of the parks and the parks having locked gates. Esq. Stump remarked that he was going to get together with Brian real soon and go over the issues. Discussion ensued regarding the parks in the County. Brian Spencer ended by saying he was going to get with Esq. Cotton regarding playground equipment.

h) Ms. Karen Spencer came before the Court as the Director of the Solid Waste Department. She reported to the Court that she tried to run everything on grants to save the County money. Right now, she did need gates. She said that they needed a portable heater. She said that they need more space and that their materials were getting wet. Judge Travis encourages the Court members and the audience to go to the Recycling Center to see how much it was used. She said that she had to attend yearly classes and file reports on a regular basis to stay legal with Frankfort.

Judge Travis wanted it noted in the minutes that the Court would be voting on this amendment again after hearing back from DLG.

The Treasurer said that this was technically the second reading of budget amendment #1 of the 2022/23 budget year. He said they were technically transferring \$1000000.00 as follows: \$250,000.00 to the Jail fund and \$750,000.00 to the general fund. He said they had money that they could amend, they may have overbudgeted some. He said a good example was the Road department which was hurting because they were waiting on FEMA money. The money was going into the Jail housing contracts, which was the biggest expense. The Treasurer said that they were audited every year, they had just been audited for the past fiscal year. The budget amendments also went to DLG, and they had to approve it.

The Sheriff came before the Court to request the referenced salary cap. He handed out information to the members of the Court. The Sheriff started out by saying that since 2019 they had built 578 new homes. He said you figured each had 3.5 people, so that was about 5,000 more people. He said that right now, the population was 19,916, which was the population in the 2021 census. He said if

they stay on track, they would be 21,000 by 2025. He said that due to Sharon's computer crash, he only had 2 years' worth of activity to give them. He gave statistics from his office for the last two years. The Sheriff described his staff and what they were currently making at an hourly rate.

• Motion made by Esq. Eldridge, seconded by Esq. Cotton to set the Sheriff's salary cap at \$905,000.00. Esq. Stump commented that the data the Sheriff gave them regarding other departments' hourly rate of pay was from counties that had a larger tax base. He said Spencer County did not have the money that these counties had.

• Motion made to amend the motion on the Sheriff's salary cap to \$870,000.00 made by Esq. Stump and seconded by Esq. Pharris. Judge Travis commented that he supported the salary cap of

\$905,000.00 and did not think the Sheriff could provide 24/7 patrol at the salary cap of \$870,000.00. Vote on the amended motion of a salary cap of \$870,000.00 as follows: "ayes" Esq. Stump and Esq. Pharris. "nays" Esq. Travis, Esq. Cotton Esq. Eldridge, and Judge Travis. Motion fails. Vote on the motion to set the Sheriff's salary cap at \$905,000.00 as follows: "ayes" Judge Travis, Esq. Cotton, Esq. Pharris and Esq. Eldridge. "nays" Esq. Travis and Esq. Stump. Motion carries.

The Clerk came before the Court to express her happiness to work with the new Court to provide services to the County in a fiscally responsible manner. She was asking for the same amount for a salary cap as she had asked for last year. She provided the Court with information on the duties that her officer performed along with comparative data on the salary caps and populations of other counties indicating that her salary cap was the lowest of the county data she provided based on population. She commented on the difficulty in finding qualified people to fill the open positions she had and told the Court the reason she did not spend her current salary cap was that she had operated short-staffed the entire year and had, at times, operated with only 2 Deputies. Her goal was to have seven Deputies so that she could provide services to the growing community. The Clerk made the point that both her office e and the Sheriff's offices were "fee" offices. The fee offices were intended to operate off the fees they generated. She said that she not only provided services to the public off the fees she collected, but she also turned over surplus funds to the Fiscal Court so they could provide services to the people of the County as well. She said that her office had accountability and that the staff put in a full day of work for a full day's pay. Her office was the only County office to use a time clock, providing more accountability. They were audited and had to ensure all funds were accounted for. She needed staff who could think critically. She explained how all the Deputies performed motor vehicle transactions and in addition, had other job responsibilities such as recording, new car deal work, lien filing and release, and bookkeeping duties. She remarked that her office staff was being stretched way too thin. The members of the Court expressed concern that surplus funds might be tied up in the Clerk's salary cap and she would not spend it. The money might be used in other places. The Clerk indicated she planned on spending all the allotted salary cap. Esq. Stump remarked that he thought the total cost of an employee was \$45,000.00 and if she was at full staff it came to \$391,000.00.

- Motion made by Esq. Stump to set the salary cap for the Clerk's office at \$391,000.00. Motion seconded by Esq. Cotton. Esq. Stump said he wanted to give people what they needed but not set the precedence of giving them what they wanted. He said this was a \$60,000.00 increase over what she received last year, even though she fell way short of hitting that mark. The Clerk asked Esq. Stump if he realized her salary cap was \$383,000.00 last year and he replied to the figure he was given was \$330,000.00. Voice vote on the motion with all members voting "aye". Motion passes

The Judge remarked that by general consent of the Court Todd Burch had asked that the Equipment committee work on this due to the wide variation in guotes for this equipment.
