An Ordinance Relating to the Annual Budget and Amendment Thereof (Budget Amendment No. 2)

Whereas, the County of Spencer has realized unbudgeted receipts for the General Fund, the Road Fund, and the Jail Fund,

Be It Ordained by the Fiscal Court of Spencer County, Commonwealth of Kentucky that:

Section One. The budget for fiscal year 2003-2004 is amended to:
