Section One: The budget for fiscal year 2007-2008 is amended to:

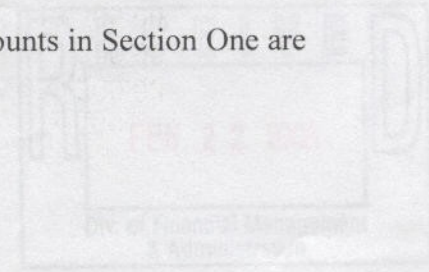
