Spencer County, Kentucky Ordinance No. 4 Fiscal Year 2005 Series

An Ordinance Relating to the Imposition of License Fees for the Privilege of Engaging in a Business or Profession Within Spencer County, Kentucky

Whereas, the Fiscal Court of Spencer County, Kentucky has determined that the imposition of business license fees for the privilege of engaging in a business or profession in Spencer County will generate revenue which will allow for the continuation and upgrading of quality essential services to the citizens of Spencer County;

Now Therefore, Be It Ordained by the Fiscal Court of Spencer County, Commonwealth of Kentucky, as follows:

- **Section 1.** Purpose. The purpose of this Ordinance shall be to generate revenues to be used for the General Fund of Spencer County in order to provide services to its citizens as deemed necessary by the Fiscal Court.
- Section 2. <u>License Fee Imposed</u>. Each person engaged for compensation in any trade, occupation, business or profession within Spencer County, Kentucky shall procure from the County an annual license and shall pay to the County a fee for such license as provided in Schedule A, hereto attached, for the privilege of engaging in such trade, occupation, business or profession.
- **Section 3.** <u>Definition</u>. As used in this Ordinance, the word "person" shall include but is not limited to corporations, joint stock companies, partnerships, associations and individuals.
- **Section 4.** <u>Date Due</u>. The license fee herein levied shall be due on the first (1st) day of July in each year. Any business created during the Fiscal Year shall be pro-rated on a quarterly basis.
- Section 5. <u>Application and Administration</u>. Each person required by this Ordinance to obtain a license shall obtain same on or before the license fee provided for herein becomes due from the <u>County Clerk Taylorsville-Spencer County Planning and Zoning Commission office</u>, and shall disclose at the time of application for such license or licenses all occupation or businesses in which he is or will be engaged during the license year. All licenses shall be issued and all fees collected by the <u>County Clerk of Spencer County Enforcement Officer of the Planning and Zoning Commission</u>. The <u>County Clerk is hereby authorized to retain in her budget five percent (5%) of any sums collected by her office pursuant to the provisions of this Ordinance in order to offset the cost of administration thereof.</u>

Section 6. <u>License Issued</u>. No business license shall be issued unless and until the aforesaid fees are paid and no individual or corporation shall engage in business, trade, occupation or profession with Spencer County, Kentucky until a business license is issued by July 1 of each year.

Section 7. Penalties. Any person, firm or corporation violating any of the provisions of this Ordinance by failure to procure proper licenses as herein required shall be deemed guilty of a misdemeanor and, upon conviction thereof, shall be fined in an amount not more than One Hundred Dollars (\$100.00) for each offense. A separate offense shall be deemed committed on each day during or on which a violation occurs or continues and may be punishable as such.

Section 8. <u>Severability</u>. The provisions of each section of this Ordinance are severable, and if any provision, section, paragraph, sentence or part thereof, or the application thereof to any person, license, class or group, be held unconstitutional or invalid for any reason, such holding shall not affect or impair the remainder of this Ordinance, it being the legislative intent of the Fiscal Court to ordain and enact each provision, section, paragraph, sentence and part thereof, separately and independently of every other.

Section 9. <u>Effective Date</u>. The provisions of this Ordinance shall be retroactively effective to July 1, 2004 and this Ordinance shall be published according to law. All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.
