DECLARATION OF A LOCAL STATE OF EMERGENCY FOR SPENCER COUNTY, KENTUCKY

Whereas, on 15 October 2012, it was determined by the Spencer County Judge-Executive and the Spencer County Fiscal Court that the Spencer County law enforcement radios and emergency alert sirens had been in and were in poor working order; and

Whereas, this situation has not been corrected in spite of many efforts and many expenditures; and

Whereas, the continuing situations leaves the County woefully underprotected; and

Whereas, this situation created a considerable hardship for the citizens of Spencer County, Kentucky; and

Whereas, local government has the responsibility to protect the citizenry;

Now Therefore, by the authority vested in me by KRS 39A.100(2), I, Bill Karrer, Spencer County Judge-Executive, do hereby declare that a state of emergency does exist in Spencer County, Kentucky, on 15 October and for a period of time afterward until the emergency conditions cease and direct that;

(1) All agencies of the County of Spencer shall cooperate to the fullest extent with the Spencer County Disaster and Emergency Services, the Spencer County Sheriff's Office, and other federal, state, county and local agencies, and shall provide such assistance as may be required for the response to this emergency.

- (2) Under this state of emergency, as provided in KRS 39A.100 (2), Spencer County Judge
 -Executive Bill Karrer can waive procedures and formalities otherwise required by the law pertaining to:
 - A. performance of public work;
 - B. entering into contracts;
 - C. incurring obligations;
 - D. employment of permanent and temporary workers;
 - E. utilization of volunteer workers;
 - F. rental of equipment;
 - G. purchase and distribution, with or without compensation, of

supplies, materials, and facilities; and

- appropriation and expenditures of public funds.
- (3) Accordingly, I am declaring, under KRS Chapter 39A.100 (2) that a state of emergency exists in Spencer County, Kentucky.
